

November 2013 Coupon Promotion Customers and New Coaches Terms & Conditions

What is the November 2013 Coupon Promotion?

Each customer or New Coach (defined below) who purchases a Challenge Pack during November 2013 will be eligible to receive one (1) \$20 Team Beachbody coupon to use towards a future purchase. Limit one (1) total coupon per customer or New Coach, regardless of the number of Challenge Packs purchased. "New Coach" means any person who purchases a Challenge Pack in November 2013 at the time of signing up to become a Team Beachbody Coach (i.e., during the Coach sign-up flow).

If I'm Eligible, When Will I Receive my Coupon?

Coupons will be delivered via email at the address on file with Team Beachbody within 7-10 business days after the Challenge Pack purchase.

Does my Coupon Expire?

Yes, all coupons will expire on April 1, 2014 at 12:00 a.m. PT.

How Can I Use my Coupon? Are There Limits on the Number of Coupons I Can Use at One Time?

Coupons must be used towards future minimum purchases of \$30 or more (including shipping charges, but excluding taxes) for select products only on TeamBeachbody.com, including Team Beachbody Coach provided websites (coupons may <u>not</u> be redeemed over the phone or used on any other Beachbody site, including Beachbody.com). Certain products may not be purchased with a coupon; see below for full details. Only one (1) coupon may be used per transaction.

Are There Restrictions on Which Products I Can Buy?

Yes. Coupons are not valid towards the purchase of: home-direct or subscription-based products (although one-time purchases of these products are allowed); Team Beachbody Club Membership fees; Team Beachbody events, Team Beachbody Coach fees (including Coach sign up or BSF fees) or other charges; Beachbody or Team Beachbody Gift Cards; or purchases made through the Coach sign up flow.

Can I Gift or Transfer the Coupon to Someone Else? What if I Lose my Coupon?

Yes, you may gift or transfer your coupon to another person by either providing the coupon code shown on the e-mail you receive from Team Beachbody, or simply forwarding the e-mail to the person. However, note that each coupon is for one-time use only and if you lose or misplace your coupon, it cannot be replaced or re-issued.

What if a Qualifying Challenge Pack is Returned?

Any coupon that you received for purchasing a Challenge Pack will be cancelled if you return your Challenge Pack.

Anything else I need to know?

including Beachbody.com). See Purchase Restrictions below. To use your coupon, visit TeamBeachbody.com, select your products and enter the specific coupon code you received via email into the applicable box on the checkout screen. Only one (1) coupon may be used per transaction (i.e., if you received multiple coupons, you may not use more than one (1) coupon on a single transaction). Any balance remaining after using your coupon must be paid with a valid credit card or other approved payment method. If you are entitled to a refund for returning any products purchased using a coupon, your refund will be for the amount you actually paid, less shipping and handling (if applicable).
